# THE REALITY OF THE EFFECTIVENESS OF THE PERFORMANCE OF THE OUTPUTS OF THE FACULTIES OF PHYSICAL EDUCATION AND SPORTS SCIENCE FROM THE POINT OF VIEW OF ADMISSION MANAGERS

#### **ABSTRACT:**

The study aimed to identify the level of effectiveness of the performance of the outputs of colleges of physical education and sports science from the point of view of the administrators of aggressions, and to identify the strengths and weaknesses of them, and the researchers adopted the descriptive approach in the style of the case study, on a sample chosen from middle school directors randomly selected (9) education directorates in each Of the governorates of (Baghdad, Basra, Diyala, and Maysan) who are in official working hours in their administrative formations for the academic year (2018-2019) of (69) managers, the measurement instrument was used in the survey to diagnose the strengths and weaknesses in the effectiveness of the performance, in addition to knowing its level according to It did not bring the views of pain Draa, and the results were handled using the Social Statistical Package System (SPSS), to be the conclusions and applications of the study in that in that physical education teachers have from the outputs of colleges of physical education and sports science an acceptable level of performance effectiveness that enables them to manage and organize their practical lessons in middle school from the viewpoint of middle school administrators And that the level of educational and social effectiveness of the outputs of colleges of physical education and sports science is not at the acceptable level from the viewpoint of principals of their preparations, and it is necessary to work to support the policy of the Ministry of Education in enabling the outputs of colleges of physical education and sports science in To increase the effectiveness of their performance in their lessons in the middle school affiliated with it, as it is the reinforcing body for the success of this lesson. It is necessary for colleges of physical education and sports science to review their educational vision approved by graduating courses to increase the level of effectiveness of the scientific and technical capabilities of their outputs.

#### **INTRODUCTION**

Mohsen Abdel Sattar notes that "Effectiveness is the best stage for a teacher of physical education and school to achieve educational, educational, and sports goals."

Hatem Ali defines her as "the organization's ability to obtain various resources and use them effectively to achieve goals as well as its ability to balance and stability."

Cookalso indicates that the concept of performance is defined as "what is author in the observational behaviors that the physical education teacher intends in his job that are related to educational and educational goals, and the focus of administrative formations associated with it because of its high importance in the workplace."

Aida Abd Al-Hussein believes that "the educational establishment seeks at the present time that the performance of the physical education teacher be effective and distinct during a coin because it helps in achieving the goals of the teacher where the performance goals have been determined."

Thus, it is possible to develop a concept for performance effectiveness in this research is that the physical education teacher performs the tasks assigned to him in a manner that achieves the required efficiency consistent with the requirements of the teaching work and the ability to achieve the desired goals and come up with results that satisfy the educational institution in which he works with those cadres and through the above definitions Many factors contributing to or affecting performance are evident, among which are personal, administrative, educational, scientific effectiveness ... and others, and this is what its endeavors seek to reach to its faculties in physical education and sports sciences.

Ribhi Mustafa defines the outputs as "includes the individuals who were trained, the productivity increase, the high level of performance, the increase in the return, the improvement of the information of the trainees, their awareness of their problems and the problems of the organization, and improving the views of individuals towards work and productivity"

Saad Al-Anazi defines it as "what the organization can produce and accomplish from the outputs (goods and services) to meet the community's need and expectations from the overall inputs (human resources, capital, information, and primary resources) obtained from the environment."(

Najam Al-Azzawi defines her as "those parts (human, material and moral inputs" that have previously been subjected to specific operations and have become interlocking and interacting outputs, and whose results may appear as soon as the training program ends.

As scientific knowledge in sports management imposes that reaching it by pursuing academic studies that deal in the language of numbers and abstracting from tardy criticism in diagnosing the strengths and weaknesses to reach individuals or formations to the level of aspiration required to improve their reality, and this calls for the study problem to be directed towards trying From the researchers to answer the following question: What is the reality of the effectiveness of performance among teachers of sports education in junior high schools who represent the labor market for the outputs of colleges of physical education and sports science from the point of view of administrators of admissions that they are administratively affiliated with?

The aim of this research is to: - Identify the level of effectiveness of the performance of the outputs of the Faculties of Physical Education and Sports Science from the point of view of the managers of aggression, and identify the strengths and weaknesses they have.

#### MATERIALS AND METHODS:

The boundaries of the research community are the principals of the 1078 middle school principals, who remain in official working hours in their administrative formations in the general directorates of education in (15) Iraqi governorates, except for the governorates of

the Kurdistan Region of Iraq for the academic year (2018-2019) whose number is formed (20) The researcher intends to go to their studies because they are a society of the study problem themselves, and they achieve various purposes of its methodology procedures, as (9) education directorates were chosen in each of the governorates of (Baghdad, Basra, Diyala, and Maysan) of them randomly, when they reached (554) director, and to accredit the researchers On a measuring instrument built on the members of this sample The same and enjoys the foundations and scientific transactions and a fitter on an exploratory sample from them as mentioned above, the main application sample was randomly chosen to reach (69) director from the remaining number of the total sample Table (1) shows the structural details of the performance

in the nine directorates in the four governorates to represent what is (5.619%) of their total society, specialized Procedures for its members to apply the performance effectiveness measure to achieve the two objectives of the study.

Measurement tool and procedures: - To reach the achievement of the study goals, the Ahmed Fares Mohsen scale was adopted for the effectiveness of the performance of the outputs of the Faculties of Physical Education and Sports Science (2019), which is one of the measures of the paper and pen type with the number of paragraphs (36) paragraph five alternatives in the positive direction distributed over areas Five with a total score ranging from (36-180) and the middle of the hypothesis (108), as shown in Table (1):

As it was applied to the sample specified in this study in each of the four governorates (Baghdad, Basra, Diyala, and Maysan) for the period from Sunday 17/4/2019 until Monday corresponding to 29/5/2019, the researchers investigated From processing the study data using the Social Statistical Package System (SPSS) version (V26) by automatically extracting the percentage values, the mean, the standard deviation, and the t-test for one sample, the weighted (mean) and the relative importance as follows

## **RESULT AND DISCUSSION:**

The results and their discussion: - To identify the level of performance effectiveness, the comparison was made with the hypothetical mean of the scale as shown in Table (2)

Values for the weighted arithmetic mean and the relative importance given in Table (3) give an indication from the viewpoint of middle school administrators about the effectiveness of the performance of the outputs of colleges of physical education and sports science, and show that the force is in a paragraph (keen to implement it for the vocabulary of his daily lesson plans) from the second area represented by administrative effectiveness, As for the weakness in a paragraph (the implementation of official events in school?) Of the third area represented by educational and social effectiveness, the researchers attribute the appearance of these results to the fact that most of the high schools suffer from a lack of sports facilities as a result of the resort of some education directorates in the governorates to seek The schoolyards for the establishment of other schools to accommodate students as a result of the population explosion, especially in the crowded popular areas of it, which called for physical education teachers to increase the effectiveness of creativity and innovation for methods that help to implement the lesson despite the small spaces to carry out its application according to what is planned in the weekly lessons schedule, either of In terms of personal effectiveness, the effect of sport on the teacher has a clear role, as is known in the various facts that field studies came to be more social than others, except that he needs to master the art of dialogue and discussion with those around him, as the researchers attribute the emergence of this As a result of the teacher's keenness to implement the vocabulary of his lesson plans from the principle of adherence to the application of laws and administrative instructions in force, however, he needs to take the suggestions of his students when planning the management of the lesson because the student is one of the pillars of the educational process that is based on (the student, the teacher, the curriculum). School principals considered that they enjoy this effectiveness as a result of their ability to influence students more

than others in instilling rooting ethics of educational values, and respect for professional work ethics, and that teachers need to have specialized teaching competencies with a physical education lesson and taking into account the uniqueness of education and this is what Most teachers noted the result of increasing the number of their students and their ability to distribute them to groups that are appropriate to the area of sporting facilities in the school, as well as stagnation in the development of its specialized capabilities to implement its lessons, and this rests with the responsibility on the preparation and training departments that it is necessary to increase coordination with the school activity departments in education directorates To take their hand towards improving these specialized capabilities and lack of coordination with athletic academics in providing support in this direction, which helps to raise the level of effectiveness of the scientific and technical potential, especially the specialist in sports sciences.

MajeedQassem believes that "the teacher of physical education can lead the lesson towards achieving educational and learning goals with a high performance effectiveness and directing it towards the desired educational development. Effectiveness is the degree to which the teacher in the school can achieve his goals whatever the capabilities used in that it represents the relationship between Achieved goals and targets. "

Raed Al-Ubaidi notes that "performance is surrounded by many interrelated and interrelated determinants of it, and it includes the performance of a physical education teacher, and many researchers in sports administration science have sought to determine performance determinants. Some studies have revealed relationships between work conditions and performance."

Abdullah Hazza believes, "The lesson of physical education does not deviate from the general framework of classroom management except this does not mean that its management is the management of the lessons

themselves, due to the characteristics that make its management differ from the management of other lessons."

#### **CONCLUSIONS:**

- Physical education teachers from the outputs of colleges of physical education and sports science have an acceptable level of performance effectiveness that enables them to manage and organize their practical lessons in middle school from the viewpoint of their middle school administrators.

- That the level of educational and social effectiveness of the outputs of the Faculties of Physical Education and Sports Science is not at the acceptable level from the viewpoint of the principals of their preparations.

- It is necessary to work to support the policy of the Ministry of Education in enabling the outputs of colleges of physical education and sports science to increase the effectiveness of their performance in their lessons in the middle school affiliated to it, as it is the reinforcing body for the success of this lesson.

- It is necessary for the Faculties of Physical Education and Sports Science to review its accredited educational vision by graduating courses to increase the level of effectiveness of the scientific and technical potential of its outputs.
